Govt. condemned vehicles of Assam Police Headquarters. It is hereby notified for general information that the following condemned motor vehicles of this office will be sold in public auction in sealed tender basis at the M.T. Branch, premises A.P.Hqrs, Ulubari, Guwahati on15/12/2016 @ 03.30 PM.

Thereby sealed tender affixing court of Rs. 8.25 (rupees eight twenty five) only are invited from the intending tenderer. The tender will be received by the under signed in this office up to 01.30 PM.

The tenderers may inspect the condemned vehicles in any working day at office hours before the auction date. The undersigned reserves the right to cancel the auction if it is found the highest bidder has not offered the reasonable rates as fixed by the valuation committee.

The following terms and conditions are laid down for submission/acceptance of the tenders:-

- The sealed tenders containing the quotation should be subscribed as a "Tender for Condemed vehicle bearing Reg. no." on the top of the envelope.
- 2. The tenderers shall deposit their security money in the form of NSC/Call deposit/Bank draft pledged in favour of undersigned at the rate specified for each vehicle along with the tender. The security deposit will be returned to the unsuccessful tenderers and in case of successful tenderers, the security will be refunded after lifting the vehicles:-
  - MMV 5,000/- for each.
    LMV 3,000/- for each.
    M/Cycles 1,000/- for each.
- The tenderer should submit tenders quoting the Registration No. of the vehicle for which tender is submitted and rate should be quoted against each vehicle both in figures and words.
- 4. The Director General of Police, Assam reserves the right to accept or reject any tender or part of the tender without assigning any reason thereof and the decision of the DGP, Assam will be final.
- 5. The tenderer may inspect the condemned vehicles at the premise of the A.P.Hqrs. during office hours on all working days.
- B.P plates and wind screen of all B.P vehicles will have to be removed and be deposited at M.T. Branch, A.P.Hqrs, Ulubari by successful bidders before lifting the vehicles.
- 7. The successful tenderers will have to lift the vehicle from the premises of the A.P.Hqrs, Ulubari within 7 (seven) days at his own cost after depositing the entire value of the auctioned vehicles.
- 8. If the successful bidder fails to collect the vehicle within the stipulated time, the security deposit will be forfeited and be deposited to the treasury without further notice.
