Due to poor response to the notice inviting tender as quoted above, sealed tenders affixing Court Fee Stamp of Rs. 8.25 (Rupees Eight and Paisa twenty five) (non refundable) only are hereby once again invited from the intending proprietors of **Motor Cycle Garage/ Motor Electricals Repairing/ Vulcanizing & Tyre/Tube changing** within G.M. 2. The tenderers must be in a position to complete the repairing works within 3 (three) days for minor works and 14 (fourteen) days for major works from the date of receipt of formal work order failing which repairing work of the particular vehicle will be transferred to any other approved garage.
3. The tenderers should have to furnish an up to date VAT/GST Registration certificate and PAN Card duly attested by a Gazetted Officer along with their tenders without which no any tender will be accepted.
4. Earnest money of Rs.5,000.00 (Rupees Five Thousand) only in form of NSC or KVP duly pledged in favour of the Asstt. Inspector General of Police (Admn.), Assam, Guwahati should be deposited at the time of submission of Tender.
5. Any alteration or modification of rates will not be allowed after the tender has once been submitted. Rates once quoted should hold good for the financial year 2017-18.
6. The Director General of Police, Assam reserves the right to reject any or all the tenders without assigning any reason thereof. The lowest rate may not be compulsorily accepted and the decision of the Director General of Police, Assam in this matter will be final and binding on the tenderers.
