**RE-NOTICE INVITING TENDER**

Sealed Re-tender affixing non-refundable court fee stamp of Rs. 8.25 (Rupees eight and paise twenty five) only are hereby invited from the local registered firms/suppliers for supply of the B.R. Vehicles/ Non B.R. Vehicles tubeless, radial tyre (run flat), radial tyre , tube, battery and rim (list of tyres, battery and rim size enclosed herewith) during the financial year 2017-2018 under the terms and condition stated below. The tenders will be received in the office of the Addl. Director General of Police, SB Assam, Kahilipara, Guwahati-19 up to 3 PM of 11-09-2017. The tenders will be opened at 4 P.M. on the same day in presence of tenderers or their authorized representatives who may like to be present. In case the office remains closed, the tenders will be opened on the next working day at the same time and venue.

**Terms and Conditions:-**

- 1) The tender must invariably be affixed with Court fee stamp of Rs. 8.25 (Rupees eight and paise twenty five) only (non-refundable) along with a forwarding letter which should be sealed duly superscribed as **Tender for supply of the B.R. Vehicles/ Non B.R. Vehicles tubeless, radial tyre (run flat), radial tyre, tube, battery and rim for the financial year 2017-2018.**
- 2) No tender will be received after the above schedule date and time.
- 3) The rates should be furnished against each item inclusive of all taxes which will be deducted from the supplier's bills and that will be deposited to the Govt. Treasury observing all formalities. There should be no over writing or crossing on the rates mentioned in the tender.
- 4) The tenderers will have to submit the following documents along with the tender, failing which no tender will be accepted.
  - a) Attested copy of firm registration certificate.
  - b) Attested copy of GST Registration Certificate.
  - c) Attested copy of income-tax clearance certificate.
  - d) Attested copy of PAN card.
  - e) Attested copy of Trade Licence.
  - f) Assam Police HQrs. firm registration certificate.
- 5) Tenderers must deposit EMD of Rs. 30,000.00 (Rupees thirty thousand) only for supply of B.R. Vehicles/ Non B.R. Vehicles tubeless, radial tyre (run flat), radial tyre , tube, battery and rim in the form of NSC/ KVP Bank draft pledged in favour of the Superintendent of Police, SB (E), Assam, Kahilipara, Guwahati-19.
- 6) The earnest money of the un-successful tenderers will be released after acceptance of rates and earnest money of successful tenderers will be retained as security money. The security money will be forfeited to the Govt. in case the selected supplier/ firm fail to supply as per indent.
- 7) The selected tenderers will be required to deliver the B.R. Vehicles/ Non B.R. Vehicles tubeless, radial tyre (run flat), radial tyre , tube, battery and rim in the office of the undersigned on receipt of the proper indent immediately. No delivery charge will be paid to the supplier/firm by the undersigned for delivery of the B.R. Vehicles/ Non B.R. Vehicles tubeless, radial tyre (run flat), radial tyre , tube, battery and rim in this office. Rate requested will be inclusive of all charges and door step delivers have to be ensured.
- 8) The selected tenderers will be bound to supply the B.R. Vehicles/ Non B.R. Vehicles tubeless, radial tyre (run flat), radial tyre , tube, battery and rim at his quoted rates throughout the year and no representation whatsoever will be entertained for enhancement of rate subsequently.
- 9) Only the best quality B.R. Vehicles/ Non B.R. Vehicles tubeless, radial tyre (run flat), radial tyre , tube, battery and rim will be accepted. The approved supplier will be required to take back the rejected B.R. Vehicles/ Non B.R. Vehicles tubeless, radial tyre (run flat), radial tyre , tube, battery and rim at his own cost.
- 10) Payment of bill will be made depending upon the availability of fund. No extra charge will be entertained if the payment is delayed due to non-availability of fund.
- 11) Earnest money of the successful tenderer who refuses to supply after final selection by the undersigned will be forfeited to the Govt.
- 12) The rates quoted for any items by the firm whenever accepted, the firm concerned should have to supply that items. In case, the firm concerned does not supply the items when asked for the same will be liable for disqualification and action will be taken accordingly.
